ORDER GRANTING SECOND JOINT MOTION FOR EXTENSION OF STAY

This matter is currently stayed until May 26, 2017. On May 24, 2017, Petitioner Veolia ES Technical Solutions, L.L.C. and U.S. EPA Region 5 filed a joint motion requesting a 180-day extension of the stay to November 22, 2017. The parties represent that "this extension will provide them with enough time to complete the settlement process."

For good cause shown, the Board grants the parties' request. This case is now stayed until November 22, 2017. The parties shall file status reports on July 31, 2017, September 25, 2017, and November 13, 2017. Each status report shall provide information as to the progress the parties have made, their plan and timeline for resolving any outstanding issues, and whether they believe that they will be able to complete the settlement process by November 22, 2017. The Board will review each status report, and assess whether the stay continues to be appropriate. If it appears that continuation of the stay may no longer be appropriate, the Board will ask the parties to file a supplemental status report to address that question. To the extent that the parties seek a further stay of proceedings beyond November 22, 2017, the parties must file a motion

requesting a further stay no later than **November 13, 2017**. The motion must specify the length of, and explain the basis for, such a further stay.
