ORDER GRANTING JOINT MOTION FOR A FURTHER STAY

On December 22, 2017, the Environmental Appeals Board (“Board”) issued an order continuing the stay of proceedings in this case until January 31, 2018, to provide EPA with time to consider comments received on the parties’ contingent settlement agreement during the public comment period and to determine whether to withdraw or withhold its consent to the agreement. The Board’s order directed the parties to file a status report and any motion for a further stay no later than January 17, 2018.

In the parties’ January 17 joint status report and motion for a further stay, EPA represents that it is considering the comments received on the contingent settlement agreement and determining whether it should withdraw or withhold its consent to that agreement. The parties request an extension of the stay until February 28, 2018, to allow additional time for EPA to consider the comments and determine whether to withdraw or withhold its consent.

Based on the parties’ representations, the Board concludes that a further stay of this case to **February 28, 2018**, is appropriate. To the extent that the parties seek a stay of proceedings beyond February 28, 2018, the parties must file a motion requesting a further stay no later than

February 21, 2018. The motion must specify the length of, and explain the basis for, such a further stay.
