ORDER

The Environmental Appeals Board ("Board") has received the "Non-Party Brief Supporting Region 1's November 30, 2006 Remand Determination" filed electronically by the Taunton River Watershed Alliance, Inc ("TRWA") on April 20, 2007. TRWA previously filed a Motion for Leave to File an Amicus Brief and a Memorandum of Law in support of Region 1's Determination on Remand. Docket No. 51, filed March 13, 2007.

On March 27, 2007, the Board issued an order accepting the TRWA and other non-party submissions filed prior to that date in connection with the above-captioned matter. In that Order, we expressly noted that we did not anticipate accepting any additional non-party briefing on this matter. TRWA's latest submission does not appear to contain any information that is particularly new or helpful to the Board.
