ORDER GRANTING MOTION TO FILE AMICUS BRIEF

By motion filed with the Environmental Appeals Board ("Board") on February 6, 2013, the New Hampshire Department of Environmental Services ("NHDES") requests leave to file a non-party amicus curiae brief in the above-captioned matter "in order to correct the record with respect to certain actions and positions alleged to have been taken by [NHDES]." *See* New Hampshire Department of Environmental Services' Motion to File Non-Party Amicus Brief and Amicus Brief, at 1 (Feb. 6, 2013) ("Motion"). The Amicus Brief is attached to the Motion. *See* Amicus Brief of N.H. Department of Environmental Services ("Amicus Brief"). According to the Amicus Brief, the petitioner in this matter, the Great Bay Municipal Coalition ("Coalition"), "has mischaracterized statements and positions made by NHDES with respect to the development of, use of, and the analyses supporting the document entitled 'Numeric Nutrient Criteria for the Great Bay Estuary' (referenced by the Petitioner as the '2009 Numeric Criteria')." *Id.* at 2. NHDES states that "the amicus brief is an attempt by NHDES to correct some of the most important mischaracterizations." *Id.*

Upon consideration, the Motion is granted and the Amicus Brief is admitted to the record before the Board. Should the Coalition wish to comment on the Amicus Brief, it may do so in its reply due on March 1, 2013.¹
