ORDER

On January 15, 2020, the parties to the above-captioned appeal filed a joint status report with the Environmental Appeals Board. They stated that they had reached a settlement agreement in principle in proceedings before the federal courts in Iowa that are parallel to the disputes raised in this appeal. *See* Joint Status Report at 1. The parties reported that negotiations regarding settlement details were ongoing, and they requested that the Board continue the stay of this matter to allow them to finalize a consent decree. *Id.* They stated that they would notify the Board within seven days of the lodging of the consent decree with the U.S. District Court for the Southern District of Iowa. *Id.*

Three months have passed since the parties last updated the Board about the status of this matter. The Board's stay of its proceedings has continued during that time and will remain in place unless otherwise explicitly lifted by Board order. To manage its docket efficiently, the Board requires an update. Accordingly, the parties are directed to submit to the Board a status report on or before **Wednesday**, **May 6**, **2020**, advising the Board of the status of the settlement process in Iowa and recommending next steps for orderly resolution of the parallel appeal

pending before the Board. Such steps should include, but not be limited to, periodic status updates to the Board until such time as this matter is resolved.
