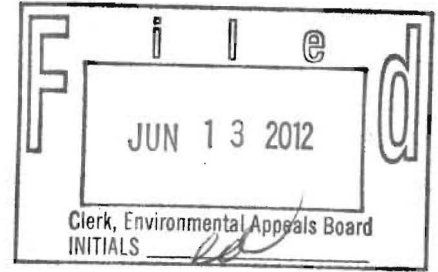

**ORDER GRANTING CHRISTIAN COUNTY GENERATION, LLC'S
MOTION FOR LEAVE TO INTERVENE**

On May 30, 2012, the National Resources Defense Council (“NRDC”) and Sierra Club petitioned the Environmental Appeals Board (“Board”) for review of Prevention of Significant Deterioration (“PSD”) permit number 02106ACB, issued by the Illinois Environmental Protection Agency (“IEPA”) to Christian County Generation, LLC (“CCG”) on April 30, 2012. The Board requested that IEPA respond to the petition by no later than June 25, 2012. Letter to John J. Kim, Director (Interim), IEPA, from Eurika Durr, Clerk of the Board, Environmental Appeals Board, U.S. EPA (June 4, 2012). In that same request, the Board notified the permit applicant, CCG, that the petition had been filed and that, if CCG wished to respond to the petition, its response would also be due no later than June 25, 2012. *Id.*; *see also Order Governing Petitions for Review of Clean Air Act New Source Review Permits*, at 10 (EAB Apr. 19, 2011) (“Standing Order Governing NSR appeals”). CCG now seeks leave to intervene in this PSD permit appeal.


The Board recognizes CCG’s interest in this proceeding stemming from its direct interest

in the permit being challenged. Therefore, in accordance with the Board's current practice, the Standing Order in NSR appeals, and the Board's letter requesting a response to the petition in this case (which included a response deadline for the permit applicant), the Board GRANTS CCG leave to intervene and to participate in this PSD permit appeal.


