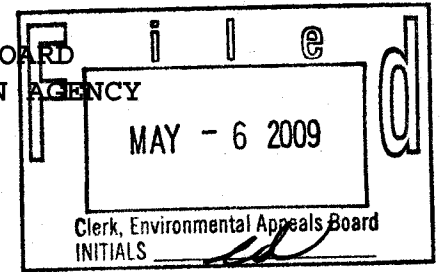

ORDER GRANTING MOTION TO EXTEND STAY OF PROCEEDINGS

On April 7, 2009, U.S. EPA Region 1 (the "Region"), with the assent of the petitioners in this case, Thomas Arnold (NPDES Appeal No. 08-26) and the U.S. Department of Interior (NPDES Appeal No. 08-27), filed a status report and a motion requesting to further extend the stay of proceedings in the above-captioned matter until June 10, 2009. To better assess the Region's report and request, the Environmental Appeals Board ("Board") scheduled a teleconference with all the parties. The teleconference was held today, May 6, 2009, at 2:00 p.m. EST.

Upon the parties' representations in today's teleconference that the parties have made substantial progress in their negotiations, and that the parties see value in continuing settlement discussions, the Board grants the Region's request for an extension of time. The proceedings before the Board are now

stayed until June 10, 2009, at which point the parties shall timely file¹ a detailed report regarding the status of these appeals and negotiations, including issues resolved, issues remaining, and any timing issues about which they believe the Board should be aware.

So ordered.


