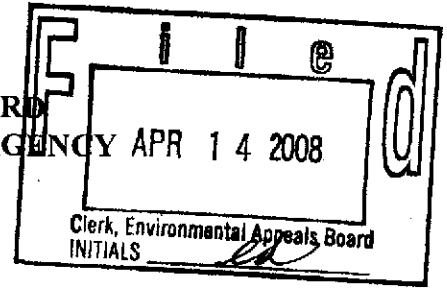

**ORDER GRANTING MOTION FOR EXTENSION OF TIME**


By motion filed April 11, 2008, petitioners Star Township, Antrim County, and Friends of the Jordan River (collectively, the "FJR Petitioners") (UIC Appeal No. 08-02) request a seven-day extension of time to file their reply to Beeland Group, LLC's ("Beeland") response seeking summary disposition of the above-captioned matter. FJR Petitioners' Motion for Extension of Time ("Motion"). The FJR Petitioners state that the additional time is needed "because their counsel will be out of the country when Beeland files its response and counsel will not be able to prepare a reply prior to April 21, 2008." Beeland does not oppose the Motion.

For good cause shown, the Motion is granted. The FJR Petitioners' reply to Beeland's response seeking summary disposition must now be filed with the Environmental Appeals Board no later than April 28, 2008.


