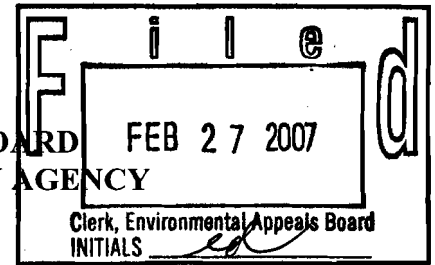

**ORDER GRANTING**

**COMPLAINANT'S MOTION FOR EXTENSION OF TIME**

On February 26, 2007, Complainant, Region 3 of the U.S. Environmental Protection Agency, filed a motion requesting a 40-day extension of time to file its response to Respondent's appeal brief, and to have the additional time applied to the time period during which Complainant may file a cross-appeal. The current deadline for Complainant to file its response to Respondent's appeal brief and a cross-appeal, if any, is March 12, 2007. In support of its motion, Complainant explains that the additional time is necessary because of the large number of issues Respondent raised in its appeal and because Complainant needs to coordinate its response with other offices within the Environmental Protection Agency involved in the Agency's practice before the Environmental Appeals Board ("Board"). Complainant further explains that, while it is not certain if it wishes to cross-appeal, it needs additional time to examine the issues raised in Respondent's appeal brief to determine the degree to which those issues are intertwined with the issues upon which Complainant is considering a cross-appeal. Finally, Complainant represents that Respondent does not oppose this request.

Upon consideration of the foregoing and for good cause shown, the Board grants Complainant's request. Complainant's response to Respondent's appeal brief, and its cross-appeal, if any, must now be filed no later than April 20, 2007.<sup>1</sup>

So ordered.


