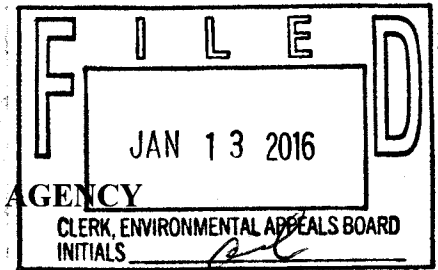

SIXTH ORDER EXTENDING STAY OF PROCEEDINGS

The parties in the above-captioned matter continue actively to participate in good faith in the Environmental Appeals Board's Alternative Dispute Resolution Program. On January 6, 2016, the parties filed a "Notification of Provisional Settlement" with the Board, reporting that they have reached provisional settlement of their disputes. The parties request a further extension of the stay of proceedings until February 22, 2016, by which date EPA Region 8 anticipates taking final action on Deseret Power's application for a minor new source permit. The Settlement Judge has recommended that the Board extend the stay until March 1, 2016, to allow sufficient time for the Region to complete its final action, and for petitioners to file motions for dismissal with the Board.

Based on the recommendation of the Settlement Judge, the Board extends the stay until March 1, 2016.


