ORDER GRANTING REPLACEMENT OF PETITION ATTACHMENT

Hecla Limited Lucky Friday Mine (“Hecla Limited”) has petitioned for review of the National Pollution Discharge Elimination System (“NPDES”) permit issued for the Lucky Friday Mine by U.S. Environmental Protection Agency, Region 10. Shortly after filing the petition, Hecla Limited requested the removal and replacement of Attachment 6 of its petition for review. Attachment 6 to the petition is labeled as “Final 401 Certification of the Lucky Friday NPDES Permit (June 3, 2019).” Hecla Limited Lucky Friday Mine Petition for Review 21 (July 22, 2019) (Attachment 6 is labeled as Exhibit F in the petition). Attachment 6, however, is a State of Idaho, Department of Environmental Quality, cover letter for Clean Water Act section 401 certifications for two different NPDES permits at two separate mines – Hecla Limited Lucky Friday Mine and U.S. Silver Coeur Galena Mines – and the certification for the U.S. Silver Coeur Galena Mines permit, which is not the permit being challenged in this appeal. As a replacement, Hecla Limited has resubmitted the same cover letter with the certification for the Hecla Limited Lucky Friday Mine permit, which *is* the permit being challenged. In the absence


of any objection from Region 10, the Board grants Hecla Limited's request for removal and replacement of Attachment 6.
