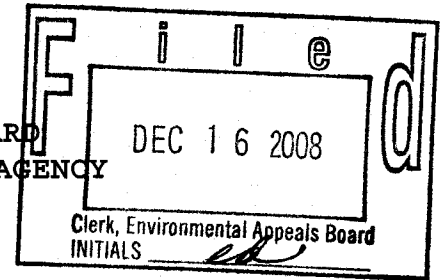

ORDER DIRECTING PARTIES TO FILE STATUS REPORT

On September 25, 2008, the parties in the above-captioned matter, U.S. EPA Region 5 (the "Region") and PPG Industries Ohio, Inc. and PPG Industries, Inc. (collectively "PPG"), filed a joint status report explaining the status of the permit modification process and their expectations for resolution of these proceedings. These proceedings have been before the Environmental Appeals Board since May 2007. Throughout the life of this permit appeal the parties have represented on numerous occasions their expectation to fully resolve this appeal by a specified timeframe, but to this date such resolution has not yet occurred. In their last report (the September report) the parties represented that they expected full resolution of this matter via permit modification and withdrawal of the appeal by the end of November or early December 2008. This expectation was confirmed by the parties in a status

conference held by the Board on November 25, 2008. It is now mid-December and the Board, again, has seen yet another assurance pass without fulfilment.

Accordingly, the Board hereby orders Region 5 and PPG to file a status report no later than Friday, December 19, 2008, explaining the current status of this case. A manager in the Office of the Regional Counsel shall provide, and sign, the status report on behalf of the Region.


