

**ORDER GRANTING THIRD JOINT MOTION TO STAY PROCEEDINGS**

On August 13, 2015, the Town of Salisbury Sewer Commission (the "Town") filed a petition seeking review of several conditions in a National Pollutant Discharge Elimination permit issued by U.S. EPA Region 1 (the "Region"). Shortly thereafter the parties filed a joint motion requesting that the Environmental Appeals Board ("Board") stay the proceedings in this case because they had agreed to engage in settlement discussions to reach a negotiated resolution of the issues raised in the Petition. The Board granted the parties' request, as well as a second request for extending the stay. The last motion the Board granted extended the stay until December 10, 2015.

The parties now seek an additional extension of the stay of fourteen days. *See* Third Joint Motion to Stay the Proceedings (Dec. 8, 2015). The parties explain that they are nearing final agreement over the terms of an administrative order and have made their best efforts to conclude their negotiations prior to the expiration of the existing stay on December 10, 2015, but need a short additional stay to allow negotiations to fully conclude in an orderly, but still expeditious, manner.

For good cause shown, the Board grants the parties request to extend the stay of these proceedings. This matter is now stayed until January 12, 2015.
