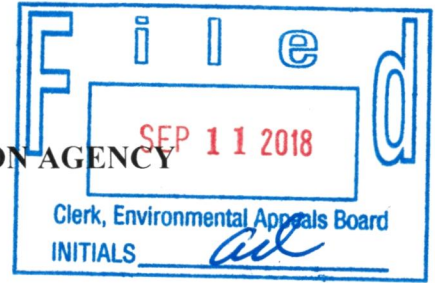

**ORDER GRANTING MOTION FOR EXTENSION OF TIME
AND SETTING DEADLINE FOR RESPONSES**

By motion filed with the Environmental Appeals Board (“Board”), Taotao Group Co., Ltd. and Jinyun County Xiangyun Industry, Co., Ltd. (collectively “Respondents”) seek a two-week extension of time, until September 20, 2018, to file their appeal brief in CAA Appeal No. 18-01. *See* Motion for Extension of Time to File Petition for Review (“Motion”). Respondents have also filed a Notice of Appeal listing the issues on appeal to the Board. In support of the Motion, Respondents state that Judge Biro’s August 7, 2018 Initial Decision in this matter is lengthy (exceeding 50 pages) and complex and that the extension will allow counsel for Respondents “sufficient time to submit an adequate appeal brief and will not prejudice” opposing counsel. *Id* at 2. Taotao USA, Inc. has also filed an appeal from the Initial Decision. *See* CAA Appeal No. 18-02.

For good cause shown, the Motion is **GRANTED**. Respondent's appeal brief in CAA Appeal No. 80-1 must now be filed with the Board no later than September 20, 2018. U.S. EPA's responses to both appeals (CAA Appeal Nos. 18-01 and 18-02) must be filed with the Board no later than October 10, 2018.
