ORDER EXTENDING STAY

By order dated November 28, 2005, the Board extended the stay of the petition for review filed by the City of Newburyport (the "City") in the above-captioned matter based on the representations of U.S. EPA Region I (the "Region") and the City that they had reached a settlement agreement but were unable to finalize the agreement until they knew the outcome of a second petition for review filed by the Island Futures Group (designated as NPDES Appeal No. 04-06).

On December 8, 2005, the Board issued an Order Denying Review in Part and Remanding in Part in NPDES Appeal No. 04-06 ("Dec. 8 Order"). In light of the Dec. 8 Order, the Board lifted the stay in this matter and ordered the parties to advise the Board no later than January 13, 2005, whether they planned to finalize their settlement agreement in NPDES Appeal No. 04-05, and whether the City planned to withdraw its Petition for Review with the Board.

In a Status Report filed¹ with the Board on January 12, 2006, the Region, with the City's assent, requests that the stay in this matter be extended. Status Report Responding to Order Lifting

Stay (Jan. 12, 2006) ("Status Report"). In support of this request the Region states that it intends to

issue for public comment a permit modification in response to the Board's Dec. 8 Order. The Region

will also initiate modification proceedings implementing the settlement agreement between the

Region and the City. The Region requests that the stay be extended until completion of the permit

modification proceedings.

For good cause shown, the Region's request is granted. The stay in this matter is extended

until August 31, 2006. In the interim, the Region shall provide the Board with status reports on the

progress of the permit modification proceedings. These status reports shall be filed with the Board no

later than April 3, 2006, and June 30, 2006.
