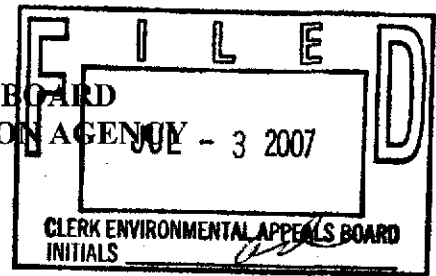

**ORDER GRANTING LEAVE TO FILE CORRECTED BRIEF**

On June 29, 2007, U.S. EPA Region 3 (the "Region") filed a notice of appeal and supporting brief in the above-captioned matter. By motion filed on July 2, 2007, the Region seeks leave to file a corrected brief "curing minor clerical errors occurring in the June 29, 2007 brief." Motion for Leave to File Corrected Brief ("Motion") at 1. The Region states that counsel for Respondent, Leed Foundry, Inc., does not object to the Motion. The Motion also states that "the Region does not object to the running of Respondent's Response filing deadline from service of today's motion."

Upon consideration, the Motion is granted. The Region's corrected brief will be admitted to the administrative record on appeal. However, given the minor clerical nature of the changes, Respondent's applicable filing deadlines will continue to run from the filing date of the Region's initial brief on June 29, 2007.<sup>1</sup>
