ORDER GRANTING FOURTH MOTION FOR EXTENSION OF TIME

On November 25, 2019, the Environmental Appeals Board (“Board”) granted an unopposed motion by Veolia ES Technical Solutions, L.L.C. (“Veolia”) for a seven-day extension of time to file a response brief to the Petition filed by the American Bottom Conservancy (“the Conservancy”). *See* Order Granting Third Motion for Extension of Time 1-2 (Nov. 25, 2019). Response briefs by EPA Region 5 (“the Region”) and Veolia are now due on December 9, 2019, and December 16, 2019, respectively. *Id.* The Board previously established a deadline of December 24, 2019, for the Conservancy to file a reply brief to any response filed in opposition to its Petition. *See* Order Granting Second Motion for Extension of Time 2 (Oct. 24, 2019).

On November 27, 2019, the Conservancy filed an unopposed motion in which it seeks a seven-day extension of time for the deadline to file any reply brief. *See* American Bottom Conservancy Unopposed Fourth Motion for Extension of Time 1-2 (Nov. 27, 2019). The Conservancy’s motion seeks an order “extending the filing deadline to December 31, 2019 for [the Conservancy] to file its Reply to EPA’s and Veolia’s Responses.” *Id.* at 2. The Conservancy states that it is requesting the extension to allow for sufficient time to reply to


responses that it anticipates will be filed by Veolia and by the Region. *Id.* at 1. The Conservancy represents that neither the Region nor Veolia opposes the motion. *Id.* at 2.

Accordingly, based on the representations in the motion, the Board **GRANTS** the motion. The Conservancy's reply to any responses filed in opposition to the Petition is due on or before December 31, 2019.
