## ORDER GRANTING SECOND JOINT MOTION

## TO STAY THE PETITION

On September 7, 2007, the parties in the above-captioned matter, U.S. EPA Region 5 (the "Region") and PPG Industries Ohio, Inc. and PPG Industries, Inc. (collectively "PPG"), filed a second joint motion requesting to stay the proceedings in this case until December 7, 2007. On July 24, 2007, the parties filed their first motion seeking to stay the proceedings until September 7, 2007, to allow the parties to conduct settlement discussions, which the Environmental Appeals Board ("Board") granted by order dated July 30, 2007. The parties represented at the time that they believe that they may be able to settle some or all of the issues raised in PPG's petition. In their current motion, the parties explain that

they have exchanged correspondence and held a face to face meeting to discuss settlement proposals, that one of the issues has been resolved, and that progress has been made with respect to the remaining four issues. However, the parties add, additional time is necessary to continue settlement discussions.

For good cause shown, the Board hereby grants the parties' request to stay the proceedings until Friday, December 7, 2007. On or before December 7, 2007, the parties shall submit a report regarding the status of the settlement negotiations which shall include a discussion of whether it is appropriate to continue the stay or dismiss the petition.
