# ORDER GRANTING REGION 9'S MOTION FOR EXTENSION OF TIME TO RESPOND TO PETITIONS FOR REVIEW

U.S. EPA Region 9 issued an NPDES permit to Buena Vista Rancheria on June 25, 2010. The Environmental Appeals Board received three petitions for review of that permit between July 21, and July 23, 2010. The Board requested that Region 9 file a response to those petitions no later than September 13, 2010. *See* Letter from the Board to Nancy Marvel, Regional Counsel, U.S. EPA Region 9 (July 29, 2010). The Board then received a fourth petition for review on August 14, 2010, and requested that Region 9 file a response to the latter petition no later than October 12, 2010. *See* Letter from the Board to Nancy Marvel, Regional Counsel, U.S. EPA Region 9 (August 30, 2010). Region 9 now seeks to file a single response to all four petitions by September 27, 2010.

In support of its motion, the Region states that the additional time to file its response to the original petitions, in conjunction with its response to the fourth petition, will conserve resources and allow a more efficient response. The Region further represents that its motion is, at least

partially, unopposed (at the time of filing, the Region had not yet received responses from counsel for two of the petitions).

For administrative convenience, the Board hereby consolidates all four petitions for review. Additionally, having duly considered this motion and for good cause shown, the Board **GRANTS** Region 9's motion for an extension of time within which to file its responsive brief to the above-identified petitions. The Region must file its response brief in these consolidated petitions no later than **September 27, 2010.** <sup>1</sup>
