SECOND ORDER EXTENDING STAY OF PROCEEDINGS

By Joint Motion filed with the Board on June 28, 2013, the United States Environmental Protection Agency, Region 1 ("Region") and the University of Massachusetts Boston ("UMass Boston"), the parties in the above-captioned matter, request that the stay of the proceedings in this matter be extended to July 31, 2013. Joint Motion to Extend Stay of Proceedings and Deadline for Region 1's Submission of Response to the Petition (June 28, 2013) ("Motion"). The Motion states that the parties have now resolved all legal and technical issues and have largely finalized a federal compliance order that would settle proceedings before the Board. Motion at 3. The Motion states further that "due to vacation schedules and the impending July 4th long weekend, * * * additional time is required to allow for final coordination with the [Massachusetts Department of Environmental Protection ("MassDEP")] before execution of the federal order is advisable. * * Once the parties receive assurances from MassDEP that the federal order as written will not conflict with the progression of the state order, the parties are prepared to seek withdrawal of the appeal and, once granted, execution of the federal compliance order." *Id.* at 3-4.

Upon consideration, the Motion is granted. The stay in this matter is hereby extended until July 31, 2013. The parties shall file a status report describing the status of settlement negotiations no later than July 17, 2013. In light of the fact that this proceeding will have been stayed for a total of 120 days as of July 31, and further, in light of the parties' representation that they have resolved all "legal and technical issues" associated with resolution of the appeal, any further stay requests will not be routinely granted absent a showing of unexpected circumstances.
