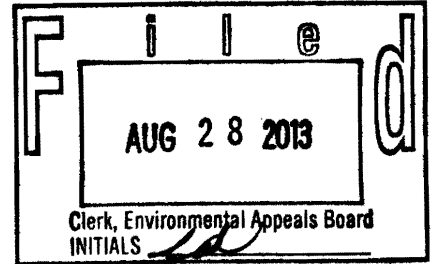

**ORDER GRANTING MOTION FOR EXTENSION  
OF TIME TO FILE PETITION FOR REVIEW**

On August 27, 2013, the United States Department of the Air Force filed a motion seeking a thirty-day extension of time to file a petition for review of NPDES Permit No. CO-R042003, issued to the Air Force by United States Environmental Protection Agency, Region 8, on August 6, 2013. The Air Force requests additional time so that it can fully evaluate the potential impacts of the contested permit conditions on its military operations, consult with the numerous military units and other government tenants that use the permitted facility, and obtain necessary approval and guidance from Air Force senior leadership. In accordance with 40 C.F.R. § 124.19(f)(2), the Air Force contacted EPA Region 8 and reports that the Region does not object to the granting of this motion.

For good cause shown, the motion is hereby **GRANTED**. The Air Force must file a petition for review of NPDES Permit No. CO-R042003 on or before **Monday, October 7, 2013**.


