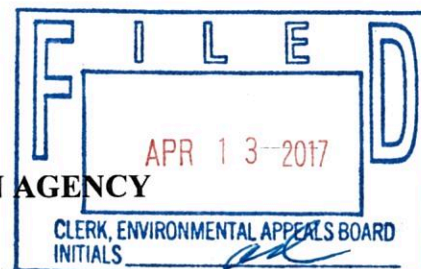

whether or not they intend to participate in the oral argument and, if so, whether they will attend in person or request to appear by videoconference.¹
