In response to your inquiry, the Board strongly discourages the use of a PowerPoint during oral argument. The primary purpose of an oral argument is for the Board to engage with the parties and to ask questions regarding the materials in the record and not to receive a presentation. Nevertheless, you may present specific pages of hard copy documents from the administrative record for this permit using the Court's on-screen touch telestration system (similar to an Elmo). You may also be able to present specific pages of documents from the administrative record for this permit directly from your laptop, but we would need to confirm that your laptop is compatible with the Board's equipment. A memory stick may not be inserted into any EPA computer for security reasons.

Please note, to the extent that you seek to present materials other than specific pages of documents from the administrative record for this permit, you must first obtain permission from the Board in advance of the argument via motion that includes a copy of the proposed materials. The PowerPoint as described in your email is not limited to specific pages of documents from the administrative record for this permit, and as such, you must file a motion for permission to present the PowerPoint if you decide to proceed in this manner. As with any motion, you are responsible for conferring with counsel for Respondent in advance of filing the motion and representing whether Respondent concurs or opposes the motion. 40 C.F.R. § 124.19(f)(2).
