Wastewater Treatment Facility Lagoons

### Dear Mr. Dawson:

Per our prior discussions with EPA and MA DEP, we have developed a proposed schedule for lining of the lagoons at the WWTF, assuming it will remain a requirement in the final NPDES Permit. This schedule includes the currently ongoing work (as presented in our letter to EPA/DEP dated September 16, 2015); reflects our best understanding of the remaining work to be completed at this time; and accounts for timing of necessary Town Meeting approvals, sufficient time for reviews and approvals at various milestones, and SRF Loan program schedule requirements. The schedule also assumes that this work will be completed independently of any other required improvements at the WWTF; understanding that the proposed schedule could be revised due to (1) completion of the analysis of the necessary lagoon volume for storage and (2) the ultimate requirements of the new NPDES permit (e.g., changes in the method of sludge handling/treatment).

#### The proposed schedule is as follows:

- October 2015 Complete collection of water level data in lagoons to allow for refined water budget.
- November 2015 Complete collection of data in the lagoons on the volume of sludge and samples for quality in October with analytical data arriving in November.
- November 2015 Update the water budget analysis
- February 2016 Complete analysis of lagoon alternatives, including sludge management, permitting plan and cost analysis.
- May 2016 Town Meeting article for funding of design of lagoon lining
- July 2016 Begin preliminary design activities

- August 2016 Submit PEF for SRF funding for construction of all WWTF improvements and CMOM planning activities.
- December 2016 Submit Draft Preliminary Design Report to EPA/DEP
- March 2017 Submit Final Preliminary Design Report
- July 2017 Submit 60% plans and specifications
- August 2017 Begin permitting process
- December 2017 Complete Final Design, including final cost estimate
- January 2018 Begin public meetings leading up to Town Meeting
- May 2018 Town Meeting article for funding for construction
- August 2018 Submit SRF Loan application with Town Appropriation for lagoon portion of construction improvements.
- October 2018 DEP issues Permission to Advertise and project permits in place
- December 2018 Open bids for construction
- January 2019 Award construction contract
- March 2019 Begin construction assuming each lagoon will be constructed in sequence due to MOPO considerations.
- December 2020 Substantially complete construction
