While your cover letter states: "The City is currently in negotiations with USEPA regarding final permit limits and a compliance schedule to achieve these limits," please be aware that these meetings are limited to discussion of a compliance schedule to achieve the permit limits. The final permit limits are subject to a separate open public comment and response process that is currently ongoing, and are not part of this discussion nor subject to negotiation.

I have discussed this distinction on a number of occasions with Joe Federico and I hope that this helps to clarify the scope of discussion for Wednesday. Please let me know if you have any questions.
