# 1 Audrey Cole:

2	Audrey Cole, President of the Housatonic
3	Environmental Action League in Cornwall, Connecticut,
4	also known as HEAL. My comments today September
5	15th, 2020 are as follows. One, monitor national
6	recovery is a phrase used to refer to the supposed
7	remedy for all of Connecticut, also known as the Rest
8	of the River. For over 20 years EPA promised that
9	HEAL's many specific concerns would be addressed when
10	the RCRA permit and scope of work for the Rest of the
11	River was released. Those promises were hollow.
12	There's no indication that monitor national recovery
13	will contain, destroy or reduce toxicity of PCB
14	contaminants in the Housatonic River sediment. And
15	HEAL can find no assurances that there will be any
16	quote, maintenance of institutional controls until
17	necessary reductions and risk have occurred, unquote.
18	Indeed, the 2020 RCRA permit as amended states in
19	Appendix C-12 in part, paraphrasing, the results from
20	the Connecticut model are very uncertain due to the
21	empirical semi-quantitative nature of the analyses.
22	As such it's not possible to predict with certainty
23	attainment or lack of attainment of the human health
24	criterion based on human consumption of water and
25	organisms of .000064 micrograms per liter in

1 |Connecticut reaches ten through 16.

2	That's EPA in consultation with Connecticut does
3	not believe that there is a basis to establish
4	alternative standards at this time. Furthermore, it
5	goes on to say on that same page, "In addition this
6	concentration of .000064 micrograms per liter cannot
7	be reliably measured using available analytical
8	techniques. Monitoring using appropriate analytical
9	techniques and reporting levels will be conducted to
10	measure progress for the standard over time
11	throughout the Housatonic River in Connecticut." End
12	of that of those quotes on C-12. In fact, in the
13	early 2000's Charles Fredette, representing the
14	Connecticut DEP at an event in Stockbridge, Mass
15	stated at the meeting when repeatedly questioned by
16	HEAL why PCB sediment testing was never done above
17	the dams in Connecticut I paraphrase Charles
18	Fredette's response, paraphrase, if we found PCBs
19	there then we'd have to deal with them, quote,
20	unquote, paraphrase.
21	Such is the state of monitored national recovery
22	in Massachusetts. PCBs are at low levels and
23	Connecticut does not want to test in the areas where
24	it's presumed they are concentrated behind the dams.
25	As HEAL understands no PCB sediment testing has been

1 done in Connecticut portion of the Housatonic River 2 since 2005. This is an embarrassment all around. We 3 object.



To not make a toxic site there, you know, 19 1,100 feet above the river, and instead think 20 creatively, seek out people in the nation; top 21 scientists and companies that are working on 2.2 remediation technology and create a plan that 2.3 actually is going to make everyone happy and proud of 2.4 It's 2020. living here. This is the time. We're 2.5 not living decades ago. And you as the EPA in your

1	silence, and really complicity in this kind of pull
2	the wool over our eyes shenanigans are just showing
3	us that you can't be trusted. And this is very much
4	part of what's happening with the Trump
5	administration of course, and the administrations in
6	the last three decades to be honest. So I really
7	think we're in 2020, we need to see this move in a
8	direction that's actually going to be viable for the
9	next several generations, for the next hundred years.
