#### Dear Mr. Tappert:

In accordance with stipulation 7 of the *Programmatic Agreement Among U.S. Nuclear Regulatory Commission, U.S. Bureau of Land Management, South Dakota State Historic Preservation Office Powertech (USA), Inc. and Advisory Council On Historic Preservation Regarding the Dewey-Burdock In Situ Recovery Project Located In Custer And Fall River Counties South Dakota,* dated March 19, 2014 (PA), the U.S. Environmental Protection Agency (EPA) is providing the enclosed signature page to all signatories and consulting parties under the PA. In doing so, EPA agrees to the terms of the PA, joins the PA as a full signatory, and will participate in implementing applicable terms of the PA. Further, EPA designates the Nuclear Regulatory Commission (NRC or Commission) as the lead agency for NHPA compliance, in accordance with 36 C.F.R. § 800.2(a)(2). Accordingly, EPA has satisfied its responsibilities under section 106 of the National Historic Preservation Act (NHPA) with respect to the Dewey-Burdock Project.

As described in the introductory recitals of the PA, EPA is processing two Underground Injection Control (UIC) Permit Applications under the Safe Drinking Water Act in connection with the project. EPA has engaged in consultation efforts with multiple federally recognized Indian tribes concerning the project. , and has participated in discussions with other consulting parties regarding the PA. The Agency has concluded that signing the PA, participating as a signatory to it, and designating the NRC as the lead agency, is an appropriate way for EPA to participate in fulfilling the federal government's section 106 responsibilities for this undertaking. The basis for this decision will be explained in detail in the Response to Comments document associated with EPA's UIC permit decisions.

While EPA has chosen to rely on the Commission's section 106 efforts for this undertaking, we will continue to implement our independent responsibilities under the Safe Drinking Water Act and other statutes.

Having signed the PA, EPA intends to support the NRC in its role as lead agency as appropriate by providing information and recommendations in connection with areas of the project where EPA has knowledge or expertise. More specifically, we intend to participate as appropriate for a signatory in accordance with the terms of the agreement, particularly as referenced in PA stipulations 5, 7, 13, 14, 15, 16, and 17. We will also forward to the Commission any relevant information we have gathered during our consultation and review efforts to date.

We look forward to continuing to work with the Commission and other parties involved in this undertaking.
