ORDER REVISING BRIEFING SCHEDULE

Before the Board are three petitions for review filed by: 1) Bill MacClarence, P.E.; 2) The North Slope Bureau ("NSB"), Inupiat Community of the Arctic Slope, and the Alaska Eskimo Whaling Commission (collectively "NSB"); and 3) The Alaska Wilderness League, Center for Biological Diversity, Natural Resources Defense Council, Northern Alaska Environmental Center, Pacific Environment; and Resisting Environmental Destruction on Indian Land (collectively "AWL"). By order dated August 6, 2008, the Board consolidated these petitions and granted a request submitted by Shell Offshore Inc. ("SOI") for leave to participate in these proceedings. Order Consolidating Petitions for Review and Granting Leave to Participate (Aug. 6, 2008). Under the Board's existing briefing schedule, the filing¹ deadline for U.S. EPA Region 10's (the "Region's") response to these petitions is August 21, 2008. The deadline for SOI's response is August 22, 2008. Finally, the deadline for any reply briefs submitted by petitioners is September 5, 2008.

By submission filed with the Board on August 8, 2008, AWL seeks a modification of the existing briefing schedule. See Request to Modify Briefing Schedule and Response to Shell Offshore

Inc.'s Motion for Expedited Review (Aug. 8, 2008) ("AWL Motion").² The AWL Motion requests that the Board establish a "contingent" briefing schedule in the event that the Region's certified index to the administrative record contains additional documents not previously made available on the Region's website. In the event that the Region's certified index includes any such additional documents, the AWL Motion requests that Board allow petitioners to file revisions to their existing petitions for review on or before September 4, 2008, "to take into account new information contained in the formal Administrative Record." AWL Motion at 4. The Region and SOI would then have until September 25, 2008 to file their responses and Petitioners would have until October 9, 2008 to file any replies. *Id.* The Region, as well as SOI, have filed responses to the AWL Motion. *See* EPA's Response to Request to Modify Briefing Schedule (Aug. 13, 2008) ("Region's Response"); Shell Offshore Inc.'s Response to Request to Modify Briefing Schedule (Aug. 14, 2008) ("SOI Response").

In its response, the Region states that the certified index to the administrative record "that EPA will file on August 21, 2008, will include a number of documents" that are not posted on the Region's website. Region's Response at 1. Under these circumstances, the Region states that it "does not oppose Petitioners' motion to modify the current briefing schedule." *Id.* However, the Region requests that it be given until October 4, 2008, to file a substantive response to the petitions for review and any revisions thereto, and that petitioners be given until October 18, 2008 to file any replies. *Id.* Similarly, SOI states that, in light of fact that the certified index to the administrative

record will include some additional documents, a revision to the briefing schedule is appropriate.

SOI Response at 3.

Accordingly, the briefing schedule in this matter is revised as follows: (1) Petitioners will

have until September 4, 2008 to file any revisions to their respective petitions in light of documents

contained in the Region's certified index to the administrative record that were not previously made

available to petitioners;³ (2) The Region and SOI will have until October 6, 2008 to respond to the

petitions for review and any revisions thereto; and (3) Petitioners will have until October 20, 2008 to

file any responses.
