## ORDER GRANTING RHODE ISLAND'S MOTION FOR LEAVE TO FILE REPLY BRIEF AND ALLOWING SUR-REPLY

submit a reply to the responses of both the permittee, City of

Attleboro (the "City"), and the permitting authority, U.S. EPA

Region 1 (the "Region"). RIDEM requests that it be given until

September 23, 2008, to submit a "short reply" to "address the

following limited points:" (1) "Refute claims in both The City's

response as well as the Region's Memorandum that the issues

raised in RIDEM failed to raise the issues below that it seeks to

present on appeal;" and (2) "clarify misstatements of law and

fact in both the City's Response and the Region's Memorandum,

including the scope of the burden borne by RIDEM as Petitioner,

and whether RIDEM's Petition carried that burden, and the

timeliness and relevance of the data referenced in RIDEM's

Petition." Petitioner Rhode Island Department of Environmental

Management's Motion for Leave to File a Reply Brief (filed Sept. 16, 2008).

Upon consideration, the Environmental Appeals Board grants RIDEM's motion for leave to reply to the City's and the Region's response to the petition. RIDEM must file its reply brief on or before Tuesday, September 23, 2008. The City and the Region may also file a sur-reply to RIDEM's reply, if they wish to do so, no later than Tuesday, September 30, 2008. No further briefing will be permitted in this case except at the specific request of the Environmental Appeals Board.<sup>1</sup>
