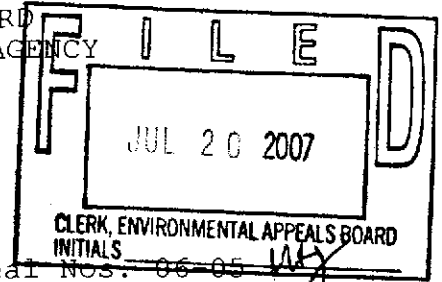

SECOND ORDER RESCHEDULING ORAL ARGUMENT

By order dated May 14, 2007, the Environmental Appeals Board ("Board") scheduled oral argument in the above-captioned matter for Thursday, August 9, 2007, at 10:30 a.m. EST in EPA's Administrative Courtroom.<sup>1</sup> Due to a scheduling conflict, oral argument is hereby rescheduled to begin at 10:30 a.m. EST on Tuesday, September 18, 2007, in the Administrative Courtroom, U.S. Environmental Protection, EPA East Building, Room 1152, 1201 Constitution Avenue, N.W., Washington, D.C. As noted in our May 14 order, the Board has allocated ninety (90) minutes total for this oral argument, divided as follows: (1) forty-five minutes for Euclid and (2) forty-five minutes for the Region.<sup>2</sup>

The parties shall notify the Clerk of the Board in writing by September 11, 2007, of the names of counsel who will present


