## ORDER GRANTING EXTENSIONS OF TIME TO FILE RESPONSE AND REPLY BRIEFS AND ADDRESSING SERVICE BY EMAIL

The Idaho Conservation League has petitioned for review of a NPDES permit issued to the City of Harrison, Idaho, by the U.S. Environmental Protection Agency, Region 10. The Region and the Idaho Conservation League have filed a joint motion requesting extensions of time for the filing of response and reply briefs as well as the certified index for the administrative record. The parties request that the Environmental Appeals Board ("Board") extend the time for filing the response brief and the certified record index to no later than October 11, 2018, and the reply brief to no later than November 9, 2018.

In support of the joint motion, the Region states that it is currently working to complete its review of thirty-six NPDES permits by the end of the calendar year and that the EPA regional attorney handling this Petition is also the permitting counseling attorney in the Region. Further, the Region states that this regional attorney, as well as other regional personnel assigned to responding to the Petition, have previously-scheduled vacations in August and September 2018. The attorney for the Idaho Conservation League states that he has previously-scheduled work travel in this time period. Both parties note that the same personnel are working on this matter

and another NPDES permit appeal, In re City of Sandpoint Wastewater Treatment Plant, EAB

Appeal No. NDES 18-01, currently pending before the Board.

Upon consideration of the joint motion for extensions of time, and for good cause shown,

the Board determines that the requested time extensions are warranted. See 40 C.F.R.

§ 124.19(n). Accordingly, the Board GRANTS the joint motion. The Region's brief responding

to the Petition and the certified index to the administrative record are due no later than October

11, 2018, and the Idaho Conservation League's reply brief is due no later than November 9,

2018.

Pursuant to 40 C.F.R. § 124.19(i)(3)(iii), the Board may use e-mail (sent under the

address: Clerk EAB@epa.gov) to serve orders and decisions in this matter at the addresses

provided by the parties. Parties shall promptly file a notice in this matter informing the Board

and the other parties if their e-mail address changes.
