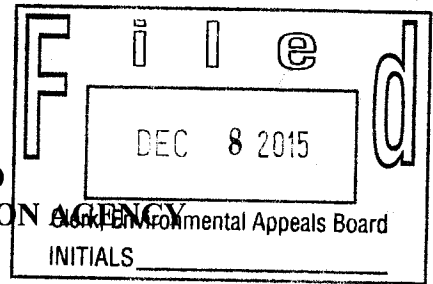

**FIFTH ORDER EXTENDING STAY OF PROCEEDINGS**

The parties in the above-captioned matter have actively participated in good faith in the Environmental Appeals Board's Alternative Dispute Resolution Program, and have reached a proposed settlement agreement. In accordance with Section 113(g) of the Clean Air Act, 42 U.S.C. § 7413(g), EPA published a notice of the proposed settlement agreement in the Federal Register on October 22, 2015, and sought public comments until November 23, 2015. *See* 80 Fed. Reg. 63,993 (Oct. 22, 2015). EPA has received several comments on the proposed agreement as is now in the process of considering these comments. The Settlement Judge has recommended that the Board extend the stay to allow EPA sufficient time to consider the comments.

Based on the recommendation of the Settlement Judge, the Board extends the stay until January 14, 2016.
