

# **ORDER GRANTING JOINT MOTION TO STAY PROCEEDINGS**

On November 4, 2015, Sterling Suffolk Racecourse, LLC, filed a Petition for Review ("Petition") with the Environmental Appeals Board ("Board") requesting review of certain conditions of the National Pollutant Discharge Elimination System Permit issued by EPA Region 1 ("Region"). On November 12, 2015, the parties filed a joint motion requesting a sixty (60) day stay in the proceedings before the Board to allow for settlement discussions. The parties represent that a negotiated resolution of the issues raised in the Petition is possible, and request the stay to allow time to coordinate discussions between their respective technical representatives and with the Massachusetts Department of Environmental Protection. The parties also ask the Board to hold in abeyance the deadline for the Region to file its response to the Petition and certified index to the administrative record.

For good cause shown, the Board grants the parties' request to stay this matter, including the Region's deadline to file its response to the Petition and certified index to the administrative record. *See* 40 C.F.R. § 124.19(n). This matter is now STAYED until January 15, 2016. The parties shall file a joint report no later than December 16, 2015, explaining the status of this matter, which shall include a discussion of recommended next steps for the efficient resolution of the pending Petition that either informs the Board of the expected timeframe for concluding settlement discussions and dismissal of this appeal or requests the Board to lift the stay. The deadline for the Region to file its response to the Petition and certified index to the administrative record is now January 15, 2016.
