

ORDER GRANTING EXTENSION OF TIME

On August 20, 2010, the U.S. Environmental Protection Agency, Region 7 ("Region"), filed a motion requesting an extension of time to respond to Titan Tire Corporation and Dico, Inc.'s (collectively, "Petitioners"), second petition for reimbursement of funds filed on May 24, 2010. The Region requests an extension of time to respond to the petition from August 23, 2010 to September 15, 2010, because the number of documents containing information relevant to the petition, some dating back prior to the 1990s, is larger than the Region originally anticipated, and thus more time than expected is required to organize and copy them for filing in this matter.
