ORDER AUTHORIZING FILING OF RESPONSE TO SURREPLY

On February 9, 2021, the Environmental Appeals Board ("Board") granted U.S. Environmental Protection Agency Region 1's contested motion seeking leave to file a surreply.¹ On February 10, 2021, counsel for Springfield Water & Sewer Commission ("Commission") contacted the Clerk of the Board via electronic mail, inquiring about the process to file a response to the Region's surreply.

A request to file a surreply or other subsequent filings is generally made by motion. After considering the facts and circumstances presented here, the Board will not require the Commission to file a motion but will allow the Commission time to file a response to the Region's surreply. Any such response must be filed with the Board on or before **Wednesday**, **February 17, 2021**. *See* 40 C.F.R. § 124.19(f), (o).

¹ In this motion, the Region did not indicate that the Springfield Water & Sewer Commission provided any reason for its opposition to the motion. The Board may act on a motion for a procedural order at any time without awaiting a response. 40 C.F.R. § 124.19(f)(6); *see also* 40 C.F.R. § 124.19(o).
