# ORDER GRANTING UNOPPOSED MOTION FOR FOURTH STAY OF PROCEEDINGS

On October 14, 2008, Region 1 of the U.S. Environmental Protection Agency filed a status report and motion to extend the stay of proceedings in the above-captioned matter. With the assent of petitioners Mirant Kendall, LLC, Conservation Law Foundation, and Charles River Watershed Association, the Region seeks an additional five weeks' stay – until November 21, 2008 – to finalize a pending proposed permit modification and the accompanying response to public comments received on that modification.

In the interest of judicial economy and for good cause shown, the Environmental Appeals Board hereby grants the motion and extends the stay of proceedings. The Region shall file a status report no later than **Friday**, **November 21**, **2008**. This status report shall advise whether the Board should extend the stay for another period of time, establish a revised briefing schedule, or take other appropriate action. The petitioners shall file their responses to the Region's status report no later than seven days after the filing of that report.
