ORDER SCHEDULING ORAL ARGUMENT

On May 12, 2008, the Michigan Department of Environmental Quality ("MDEQ") issued Prevention of Significant Deterioration ("PSD") Permit No. 60-07 to Northern Michigan University ("NMU") pursuant to Clean Air Act § 165, 42 U.S.C. § 7475. The permit authorizes NMU to construct a new circulating fluidized bed boiler at the university's Ripley Heating Plant on its campus in Marquette, Michigan. On June 13, 2008, the Sierra Club filed a petition for review of NMU's permit, raising a series of challenges to MDEQ's decision to issue the permit and requesting an opportunity to participate in oral argument before the Environmental Appeals Board. On August 5, 2008, MDEQ filed a response to the Sierra Club's petition, and on August 22, 2008, by leave of the Board, the Sierra Club filed a reply to MDEQ's response. Finally, on September 5, 2008, NMU sought leave to intervene in this case as a party, which the Board granted. NMU is expected to file a response to the Sierra Club's petition on or before September 22, 2008, and the Sierra Club and MDEQ may file responses thereto, if they so desire, no later than October 1, 2008.

After reviewing the appellate briefs filed to date and various portions of the permitting record, the Board has determined that oral argument will assist it in its deliberations regarding

PSD Appeal No. 08-02. Accordingly, the parties to this appeal are hereby requested to

participate in oral argument beginning at 10 a.m. EDT on Wednesday, October 22, 2008, in the

Administrative Courtroom, U.S. Environmental Protection Agency, EPA East Building,

1201 Constitution Avenue, N.W., Room 1152, Washington, D.C. The Board has allocated

eighty minutes for this oral argument, divided as follows: (1) forty minutes for the Sierra Club;

(2) thirty minutes for MDEQ; and (3) ten minutes for NMU. The Sierra Club will proceed first

and may reserve ten minutes of its allotted time for rebuttal if it so chooses. MDEQ will proceed

second and NMU third; each of these parties may reserve five minutes of their allotted time for

surrebuttal if they so desire.

The parties must notify the Clerk of the Board in writing by Wednesday, October 8, 2008,

of the names of counsel who will present oral argument on October 22nd. If counsel for any of

the parties wishes to participate in the argument using the EPA video-conferencing equipment in

the Administrative Courtroom, counsel must contact the Clerk of the Board, at 202-233-0122,

also by Wednesday, October 8, 2008, to make arrangements for the use of such equipment.
