# JOINT STATUS REPORT AND MOTION TO CONTINUE THE CURRENT STAY OF THE PROCEEDINGS

Region 1 of the United States Environmental Protection Agency ("Region") and Sterling Suffolk Racecourse, LLC ("Suffolk") are providing a joint status report on their ongoing efforts to settle this matter and respectfully request that the Environmental Appeals Board ("Board") extend the stay of proceedings in this matter in order to allow the parties an additional sixty (60) days to complete settlement negotiations. The grounds for this motion are discussed below.

#### 1. Background

On November 4, 2015, Suffolk filed a Petition for Review with the Board requesting review of certain conditions of a National Pollutant Discharge Elimination System ("NPDES") permit issue by the Region authorizing discharges from Suffolk Downs, a horseracing facility located in Revere and East Boston, MA, into a receiving water named Sales Creek and adjacent wetlands.

On November 12, 2015, Suffolk and the Region filed a joint motion requesting the Board to stay proceedings in the case to allow the parties to pursue settlement discussions. The Board granted the motion, ordering the parties to file a joint status report by December 16, 2015, and staying the proceedings until January 15, 2016. See *Order Granting Joint Motion to Stay Proceedings* (November 16, 2015).

## II. Status Report

Suffolk and the Region have been engaged in an exchange of information and settlement positions that included a meeting between representatives of the two parties to discuss the issues on appeal in mid-November. Since that meeting, Suffolk's engineer has been working to assemble information necessary for Suffolk to develop a written proposal to submit to the Region for resolving these issues. At the EPA's request, Suffolk drafted an initial written proposal and provided it to the EPA, on December 10, 2015. In addition, Suffolk's engineer is assembling supporting data for Suffolk's proposal.

The Region is reviewing Suffolk's proposal, and will need to review the supporting data to be provided by Suffolk. When this review is completed, the Region will provide a response to Suffolk. It is likely that there will be a need for further discussion and additional exchanges of information between the parties before agreement can be reached. Resolution of these issues is likely to be further delayed due to holiday schedules and other commitments.

#### III. Grounds for Extension of Stay

The parties are materially progressing toward a negotiated resolution of the appeal. Although the parties are not yet in a position to ascertain whether they will ultimately be able to resolve the issues on appeal through settlement, the discussions to

date have been constructive and the parties share an interest in arriving at a negotiated agreement, if possible. Accordingly, Suffolk and the Region respectfully request that the Board stay the above-captioned matter to provide the parties with additional time to conclude negotiations, taking into account the technical complexity of the issues on appeal and the difficulty of coordinating schedules during the holiday season. The parties request that the Board stay the proceedings for an additional sixty (60) days from January

15, 2016, to March 15, 2016. Under the proposed schedule, the parties would file a joint

status report with the Board by no later than February 15, 2016. At that time, the parties

will either inform the Board of the expected timeframe for concluding settlement

discussions and dismissing the appeal or will request the Board to lift the stay and

establish a new deadline for the Region to file its Response and certified index.

#### **CONCLUSION**

For these reasons, and to conserve administrative and judicial resources, the parties respectfully request that the Board issue an order staying the proceedings for an additional sixty (60) days.
