JOINT MOTION FOR STAY OF THE PROCEEDINGS

Region I of the Environmental Protection Agency ("Region"), Respondent, and the North & South Rivers Watershed Association, Inc., Petitioner, respectfully submit to the Environmental Appeals Board ("Board") this Joint Motion for Stay of the Proceedings in the above-referenced appeal until June 20, 2006.

On January 26, 2006, EPA reissued a National Pollutant Discharge Elimination System ("NPDES") Permit, No. MA0101923 ("Permit"), to the Town of Rockland, Massachusetts Board of Sewer Commissioners authorizing wastewater discharges from the Rockland Wastewater Treatment Plant into the French Stream and establishing effluent limitations, monitoring requirements, and other conditions for such discharges. On March 1, 2006, the North & South Rivers Watershed Association filed a petition for review by the Board contesting the Permit's compliance schedule, effluent limitations for nutrients, and infiltration/inflow control plan. The Board directed the Region to submit a response by April 21, 2006 that addresses the Petitioner's contentions and whether the Petitioner has satisfied the requirements for obtaining review.


The parties believe that resolution of some or all of the issues in this appeal is possible

and have agreed to enter into settlement discussions. A settlement of some or all of the issues in this appeal will simplify or resolve the issues before the Board and thus conserve the Board's resources. Additionally, the EPA permit writer responsible for issuing the Permit was deployed on a temporary assignment to assist in EPA's hurricane response efforts in Louisiana, beginning on March 20. He is expected to return on April 12, 2006.

For the foregoing reasons, the Region and the North & South Rivers Watershed Association request a stay the proceedings before the Board in this case until June 20, 2006. On or as soon as possible before that date, the Parties will submit a status report to advise the Board whether it is appropriate to continue the stay, dismiss the Petition, or establish a schedule for EPA's response to the Petition.


