**WITHDRAWAL OF PETITION FOR REVIEW
OF
ALEXANDER VALLEY ASSOCIATION**

The Alexander Valley Association ("AVA") respectfully withdraws its petition for review of NPDES Permit Number CA0005241 ("Permit"), which the U.S. Environmental Protection Agency, Region Nine issued to the Dry Creek Rancheria Band of Pomo Indians ("Permittee") on April 30, 2007. The County of Sonoma and Permittee have negotiated a comprehensive Memorandum of Agreement intended to address, *inter alia*, the AVA's concerns about the Permit.

The AVA appreciates the Environmental Appeals Board's granting of multiple briefing extensions to allow the parties to negotiate the Memorandum of Agreement. The extensions facilitated the parties' negotiations toward a final agreement.


