The Environmental Protection Agency (EPA) is providing notice that a Petition for Review has been filed with EPA's Environmental Appeals Board (EAB) for a Resource Conservation and Recovery Act (RCRA) Hazardous Waste Treatment and Storage Permit issued by EPA Region IX on September 25, 2018 for the Evoqua Water Technologies, LLC facility located at 2523 Mutahar Street, Parker, Arizona 85344 (the Facility).

Pursuant to Title 40 of the Code of Federal Regulations (40 CFR) §124.16(a)(2), EPA Region IX hereby identifies the following stayed provisions of the permit for the Facility: 1.A.6. (only as to the status of the tribal government landowner as a co-permittee), 1.E.13.a., I.L.1.c. (only as to the last sentence of that permit condition), II.M.1.b. (only as to: [1] Module V, with respect to the first sentence of that permit condition; and [2] the last sentence, before the brackets, of that permit condition), II.M.1.c., IV.G.1. (only as to Tank T-11), V.C.1.b., Table V-1, V.C.4.a., Table V-3., V.C.5., V.C.6.c., V.E., V.G.2., and V.I.

Also, in accordance with 40 CFR §124.16, EPA Region IX is hereby providing notice that all other conditions of the Final Permit will become fully effective enforceable obligations of the Permit as of December 1, 2018.

Any challenges to the Final Permit decision must exhaust the administrative appeal procedures prior to any action seeking judicial review of the Final Permit decision. Additional information regarding petitions for review may be found in the "Environmental Appeals Board's Practice Manual" available in pdf format on the EAB Guidance Documents section of the EAB website at <u>http://www.epa.gov/eab</u>.
