STATUS REPORT AND JOINT MOTION FOR FURTHER STAY OF THE PROCEEDINGS

Region I of the Environmental Protection Agency ("Region"), Respondent, and the North & South Rivers Watershed Association, Inc., Petitioner, respectfully submit to the Environmental Appeals Board ("Board") this Status Report and Joint Motion for Further Stay of the Proceedings in the above-referenced appeal until February 20, 2007.

On January 26, 2006, EPA reissued a National Pollutant Discharge Elimination System ("NPDES") Permit, No. MA0101923 ("Permit"), to the Town of Rockland, Massachusetts Board of Sewer Commissioners authorizing wastewater discharges from the Rockland Wastewater Treatment Plant into the French Stream and establishing effluent limitations, monitoring requirements, and other conditions for such discharges. On March 1, 2006, the North & South Rivers Watershed Association ("NSRWA") filed a petition for review by the Board contesting the Permit's compliance schedule, effluent limitations for nutrients, and infiltration/inflow control plan. The Board directed the Region to submit a response by April 21, 2006 that addressed the Petitioner's contentions and whether the Petitioner had satisfied the requirements for obtaining review.

On April 10, 2006 and June 27, 2006, the Board granted the parties stays of the proceedings until June 20, 2006 and October 20, 2006, respectively, to enable the parties to continue negotiations to reach a settlement of the issues raised in the petition for review. During the past four months, the parties have reached final agreement on the terms of a settlement that will include, among other items, a modification to the compliance schedule for the final phosphorous and ammonia effluent concentration limits. The parties have also obtained agreement with the terms of the settlement from the permittee, the Town of Rockland. The parties seek an additional four (4) month stay of the proceedings in which EPA will issue a draft permit modification with a thirty (30) day comment period, review comments and prepare a response to comments, and issue a final permit modification.

For the foregoing reasons, the parties respectfully request a four (4) month stay of the proceedings before the Board in this case until February 20, 2007. On or before that date, the parties will file a Status Report with the Board indicating whether the permit modification has been finalized and the appeal withdrawn, or, if not, whether additional time is needed to complete the modification or alternatively whether a briefing schedule should be established.
