
JOINT REQUEST FOR EXTENSION OF STAY

Now comes the United States Environmental Protection Agency, Region 5 and PPG Industries Ohio, Inc. to jointly request that the Board issue an Order continuing the stay of these proceedings to allow the parties time to finalize and implement the agreed resolution of this matter. In its June 24, 2008, Order the Board indicated that it would entertain further requests for extension only if the parties could represent by July 16, 2008, that "all terms necessary to settle this matter have been successfully negotiated."

The Parties have successfully negotiated all terms necessary to settle this matter. They require further time, however, to obtain final approval of the agreed terms, to determine the appropriate vehicle for making the agreed modifications to the permit, and to implement those modifications.

The parties therefore respectfully request that the Board issue an Order continuing the stay in these proceedings until September, 2008, at which time the parties will provide the Board with an update on the status of their progress with indication as to whether or not future proceedings are needed.
