Enclosed is a petition dated October 16, 2006 (received by the Environmental Appeals Board October 16, 2006) filed by Jeffrey T. Blake, Gregg J. Corbo, Attorneys, Kopelman and Paige, P.C. on behalf of the Town of Northbridge and the Northbridge Wastewater Treatment Plant, asking the Environmental Appeals Board to review a permit determination issued by the United States Environmental Protection Agency, Region 1 and the Department of Environmental Protection Commonwealth of Massachusetts in this case.

To assist the Environmental Appeals Board in deciding whether the matters raised by petitioners should be reviewed, please have your staff prepare a response that addresses the petitioners' contentions and whether petitioners have satisfied the requirements for obtaining review under 40 C.F.R. §124.19(a). Include relevant portions of the administrative record with the response, together with a certified index of the entire administrative record. Please file an original (signed in blue ink) and five copies of these materials no later than December 4, 2006, and send a copy of the response and the certified index to petitioners with a certificate of service showing the date and method of service. <sup>1</sup>

<sup>1</sup>The Environmental Appeals Board has an innovative system that allows parties to submit copies of documents, including exhibits, electronically in PDF. Instructions on registration and document submission, are available by using the "Electronic Submission" link on the Board's website. Please note that, at the present time, electronic submissions will not be considered a substitute for filing an original document with the Clerk of the Board. The Clerk of the Board still must actually receive the original document by the document's due date in order for it to be timely filed. However, Agency offices and private parties that use this system for submitting electronic copies will be excused from the requirement to submit multiple paper
