To Whom It May Concern:

Enclosed please find another copy of ESSROC's petition for review of the abovecaptioned RCRA permit. The original copy (signed in blue ink) and five copies were sent to the EAB's Colorado Building address as directed by Ms. Margaret M. Guerrero's letter dated June 5, 2013. A copy of Ms. Guerrero's letter is enclosed. Today, I received the UPS Tracking Update for the package advising that "The receiver has moved. UPS attempting to locate receiver to complete delivery, no delivery was made." Upon receipt of the Tracking Update, I went to the EAB's web page and learned that the address for UPS delivery had changed. A copy of the Tracking Update is included with this letter.

This letter is directed to the address listed on the web page. We will provide the new address (listed above) to UPS so that it may complete delivery on the original package sent on July 3, 2013 for "Next Day Air" delivery. A copy of the New Delivery Address Confirmation from UPS is included with this letter.

I called the EAB this afternoon. There was no answer. The recorded message did not indicate that the office was closed or open. I left a detailed message seeking to confirm receipt of the petition or additional directions on filing. I have not received a response.

Additionally, as directed by Ms. Guerrero's letter, we also sent a copy of the petition to EPA Region V on July 3, 2013 for "Next Day Air" delivery. The UPS Tracking Update reports that on today's date, "Delivery rescheduled due to the holiday." A copy of the Tracking Update is included with this letter.



Dear Mr. Conn:

Enclosed is a copy of the final EPA portion of the Resource Conservation and Recovery Act (RCRA) permit for ESSROC Cement Corporation (ESSROC), Logansport, Indiana.

This draft federal RCRA permit was publicly noticed in the "Pharos-Tribune" on July 22, 2012, and a copy of the draft federal RCRA permit was made available for review at the Logansport-Cass County Public Library, 616 East Broadway, Logansport, Indiana 46947. The public comment period extended from July 22 to October 23, 2012.

ESSROC submitted the only comments that the U.S. Environmental Protection Agency received regarding the draft federal permit during the public comment period. EPA's response to the comment is enclosed with this letter.

Eligibility to appeal the federal permit is discussed in 40 CFR § 124.19. Please note that if you chose to petition to appeal this permit decision, all original documents are to be signed in blue ink with five copies marked as such. EPA must receive the petition for review in Washington, DC via U.S. Postal Service at the address indicated below within thirty (30) days after service of notice of the final permit decision.
