

JOINT MOTION FOR LEAVE TO CONDUCT SETTLEMENT DISCUSSIONS

On May 7, 2007, PPG Industries Ohio, Inc. and PPG Industries, Inc. ("PPG") filed a Petition for Review of Federal RCRA Permit No. 0HD004-304-689. USEPA filed a response to the Petition for Review on June 22, 2007. The parties, having conferred, believe that there is a reasonable basis to believe that they may be able to settle some or all of the remaining issues raised in the Petition. Therefore, the parties jointly request that the Environmental Appeals Board stay these proceedings until September 7, 2007 to allow the parties an opportunity to conduct settlement discussions without the need for further litigation.
