Enclosed is a petition dated April 6, 2007 (received by the Environmental Appeals Board on April 9, 2007) filed by Luke W. Cole, Christine Billy, and Elena Gil, Attorneys, on behalf of Kivalina, asking the Environmental Appeals Board to review a permit determination reissued by the United States Environmental Protection Agency, Region 10 in this case.

To assist the Environmental Appeals Board in deciding whether the matters raised by petitioners should be reviewed, please have your staff prepare a response that addresses the petitioners' contentions and whether petitioners have satisfied the requirements for obtaining review under 40 C.F.R. §124.19(a). Include relevant portions of the administrative record with the response, together with a certified index of the entire administrative record. Please file an original (signed in blue ink) and five copies of these materials no later than May 29, 2007, and send a copy of the response and the certified index to petitioner with a certificate of service showing the date and method of service. ¹

¹The Environmental Appeals Board has an innovative system that allows parties to submit copies of documents, including exhibits, electronically in PDF. Instructions on registration and document submission, are available by using the "Electronic Submission" link on the Board's website. Please note that, at the present time, electronic submissions will not be considered a substitute for filing an original document with the Clerk of the Board. The Clerk of the Board still must actually receive the original document by the document's due date in order for it to be timely filed. However, Agency offices and private parties that use this system for submitting electronic copies will be excused from the requirement to submit multiple paper copies with their original filing.

All documents, including the materials due May 29, 2007, must reference the appeal number. **IMPORTANT**: In addition, any envelope or other packaging containing documents sent to the Environmental Appeals Board's mailing address or hand-delivery address, as prescribed below, must bear a complete and accurate return address in the upper left hand corner.
