Hecla Mining Company, Lucky Friday Unit (“Hecla”) and the United States Environmental Protection Agency (“EPA”)(collectively referred to as the “Parties”) jointly file the following Stipulated Table of Conditions Before the Board (“Stipulated Table”). The Stipulated Table is being filed by the Parties to assist the Environmental Appeals Board (“Board”) by clarifying the issues to be presented at oral argument on July 13, 2006. The Parties agree that three issues remain before the Board – total recoverable effluent limits for metals; upper pH upper limit; and whole effluent toxicity testing requirements. The Stipulated Table identifies the conditions subject to Hecla’s Petitions for Review, the status of each, and indicates in bold the three conditions still pending before the Board that will be addressed at oral argument.
