Pursuant to the Environmental Appeals Board's ("Board") January 9, 2020 Fifth Order Continuing Stay of Proceedings and Requiring Additional Status Reports in this matter, the parties, by and through their counsel, respectfully provide this nineteenth Joint Status Report.

There have been two changes to report from the eighteenth Joint Status Report filed on February 4, 2020.

1. On July 28, 2020, the Court granted the parties' Joint Motion to Enter Seventh Amended Case Management Scheduling Order, and the new schedule reflects an agreed extension of expert discovery, which was completed on August 14, 2020, setting subsequent pre-trial schedule deadlines, and retaining the matter on the February 2021 trial docket. 2. On October 2, 2020 the Court granted the parties' Joint Motion to File Oversized Summary Judgment Briefs, granting the parties a combined total of an additional fifteen (15) pages for their summary judgment briefs (Motions, Responses, Replies).
