Hi Jean,

Attached please find a plan showing our assessment units (AUs), sampling stations and pollutants causing impairment on the Ashuelot River in the vicinity of the Keene WWTF. In addition a document showing the sampling station, date and DO results used to list the various AUs in the vicinity of the Keene WWTF on the 2006 303d list is enclosed (DO impairments are highlighted in yellow). Please note that various AUs in the vicinity of the WWTF are listed as impaired for pollutants other than DO. However, it was the DO impairments which initiated the Ashuelot River DO TMDL.

With regard to sources we can only select those offered in the EPA Assessment Database (ADB). Further, the sources listed on our 303(d) list are usually just based on best professional judgement (BPJ) as actual source(s) of impairment and the degree to which they cause impairment aren't known until a TMDL is done. I believe we chose "municipal (urbanized high density area)" for NHRIV802010301-11 (which includes the Keene WWTF) because the DO violations were located up and downstream of the WWTF. Consequently DO violations were not due entirely to the Keene WWTF but rather to a combination of NPS and PS source. Of the available ADB sources, "municipal (urbanized high

density area) seemed to be the most appropriate for this instance.
